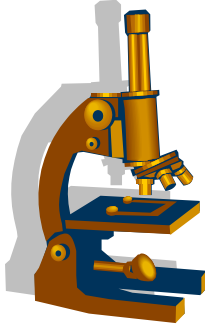

We are encouraging works to be in a range of media. Your choice of medium and style – painting, textiles, mosaics, photography, ceramics etc. The artwork **including frame is to be no larger than (A5) 15CM X 21CM (make sure to measure your frame)**

CONDITIONS OF ENTRY

- Size of work must comply with rules of the exhibition.
- Maximum of FOUR entries per artist. Entry fee \$5.00 per work for non-members of the Gallery. Free for members.
- The Committee reserves the right to refuse work deemed unacceptable for any reason.
- All works to be labelled on the back with artist's name, title of work, medium, size (cm) and price.

• SIZE OF WORKS

- The artwork including frame is to be no larger than
- A5 – 148mm x 210mm - note: an A4 sheet folded in half equals an A5
- 3D entries MUST fit inside A5 dimensions with maximum height of 15cm

- All works must be delivered framed or blocked and ready to hang (D hooks preferred). The display team reserves the right to determine the most appropriate means of displaying work.
- While the Courthouse Gallery is secure and great care will be taken with your work, the Courthouse Gallery accepts no liability for loss, damage or theft of your work. It is the artist's responsibility to arrange insurance cover, if desired, for all work.
- **NOTE: NO LATE ENTRIES OR DELIVERIES WILL BE ACCEPTED AND THE SIZE LIMIT WILL BE STRICTLY ENFORCED – ANY ARTWORKS OUTSIDE THE ABOVE GUIDELINES WILL NOT BE HUNG.**
- For artists who wish to sell their work, commission is 20% of the listed price
- Payment for sold work will be paid by cheque to the artist within two weeks of the conclusion of the exhibition.
